Judy Hull and Karen Mayfield discussed new site plan for General Truck in the City of Toledo on Suder Ave.

Focus right now is the impact the trucking facility will have on the wetlands.

The wetlands cannot operate as a filter effectively for all the waste that goes down river and into the lake, due to the removal of trees and proposed retention pond.

The waste and run off from the facility will completely deplete the wetlands.

Federal Government is trying to preserve and create wetlands.

Wetland on Suder Ave. will be extinct.

General Truck Sales wants to tap into our storm sewer lines that are already taxed when it rains.

The Township needs to urge the Lucas County Commissioner regarding the environmental issues with the Category 3 wetland, and the effect on our water.

Road Salt alone from all the proposed asphalt will impact the retention pond and thus our wet land.

We did not realize the environmental impact at the time of proposal.

Sediment fence issue was not handled properly.

Investigation for storm water violations is on going at this time.

A meeting is scheduled on September 10, 2015 with the Toledo Lucas County Plan Commission.

Request the trustees send letters to the county and state, and attend the meeting to represent the Township.
