#### MRS. VAIL-NIXON

I want to commend the Road Crew for their up keep on the roads during this winter season through all the snow and ice.

I want to commend and thank Ms. Bodette and Kim Kay for their work getting prepared for the Audit. Read the report from the State Auditor.

We completed payments on the pumper truck last year and that was \$19,726.00 in a year. Also see that we will not have \$2,600.00 coming out for real estate taxes. Would like to consider paying for Turn Out Gear and New Squad since you won't have those previous amounts coming out of Fire Department Budget. Would like to revisit this at the March meeting.

Attended the county meeting held in regards to the new jail location. Spoke to Commissioner Pete Gerkan, Washington Local School Superintendent Dr. Hayward and Washington Local School Board Member Lisa Canales.

Called Bill Harbert of the Lucas County Plan Commission and discussed zoning issues. We are going to set up a meeting. I had him send us a copy of the Zoning Regulations from their file so we can work from that copy going forward. Meetings for the Zoning Boards are set for next week.

Met with fire department officers at Monday's officers meeting and discussed the repairs to the generator, future plumbing needs and to get the fire app installed on my cell phone.

Spoke to Chief Kaiser regarding the personnel matter from last meeting. That situation is resolved and requires no further action from the Board.

We also spoke about the need for new computers (MDT) in the cars as ours will not be supported after software upgrades next year. This will also affect the fire department, 8 units total. We need to approve 1 for the new car now. The new police SUV was delivered and we need to approve the fit out of that car.

Met with Ray Doriot our Verizon representative to get the account updated with me as a contact person and discuss future needs.

#### CHIEF KAY

Mutual Aid with City of Toledo Fire for water/ice rescues.

Captain Yunker and Firefighter Joe Reames attended training for 3 days with Dive Rescue International at Jerusalem Township Fire Department for water and ice rescue emergency training. Because of the investment we made in these two to go to this training they now have the capability to certify our other firefighters without having to go to outside sources.

Currently have 28 active firefighters including day shift staff that work the Monday -Friday shifts.

Discussion regarding cleaning of linens and equipment from calls fire department go on. Have nowhere to wash linens or even a sink to clean items that need to be cleaned from calls. Suggest getting bids to get something in station to take care of this. Firefighters really help out with small repairs around fire department so we don't have to pay the expense for outside companies to come in and charge a lot to do.
