Attended the Lucas County Township Association's Annual Meeting and Dinner. Police, Fire, Administration staff and Zoning were all represented at the meeting. Attended our Zoning Boards Organizational Meeting.

Met with township resident Bob Kneisley and his neighbor after the zoning meetings to discuss the flooding problems at the end of Shoreland Avenue. I showed them maps of the storm water system in that area and the steps we are taking to deal with the problem.

Worked on 5420 Patriot , Whiting Appeal in regards to the court ordered reimbursement for cost incurred in the blight removal in 2016. We will drop our challenge to that court order because we were reimbursed by a special assessment on the taxes. The newest special assessment for blight removal in 2018 was paid by the bank this January. Received a phone call from the company that purchased 6101 Windamar about the special assessment on the taxes for blight removal, before they purchased the property. Explained to them about a paragraph in the Sheriff's deed they received that said they were responsible for the taxes and special assessments on the property due or coming due when they bought it.

Met with the Lucas County Engineering staff for our annual meeting to discuss upcoming projects for the year, including storm water problems at the end of Shoreland and the repaving of the Creekside Glens 1 Subdivision and Summit Street in 2020. We discussed the safety concerns about the number of accidents at Summit and Shoreland, and how to improve the safety at the intersection.
