REPORTS

MRS. VAIL-NIXON

Thanks to Kim Kay for working on the property damage insurance surcharge fee for the office copier and getting the paperwork together which allowed us to be reimbursed and saving us \$701.40.

The Extractor Grant has finally been approved. We received letter on September 4, 2018 and should receive the check within 8 weeks. The check will be for \$6,162.50.

Have been working on wage increases for the township employees.

Spoke to Realtor regarding the property at corner of Shoreland and Summit: they do have a buyer and planning on closing.

Have been researching Grants that we could apply for. Have been working on Facebook page and looking for new things to post.

MR. MAYFIELD

Spoke to a neighbor of the Ferguson house on Villamar about the house's condition and insect and rodent infestation. I want to cite Mr. and Mrs. Ferguson into court. Met with Sara Rowland, Lucas County Engineer, at the Creekside Glens 1 subdivision and reviewed the work needed to redo the streets. Lucas County wants to piggyback the repaving of Summit Street into our grant to allow them to get grant money also for that project.

The estimated cost for Creekside only is \$470,000.00 and with grant and engineering cost removed the cost to us would be \$218,390.00. At this time Becky says we cannot

afford it and we will with draw our application.

Creekside Glens 2 street resurfacing cost \$320,000.00 ten years ago with all new curbs and this project was quoted with spot curb repairs only at \$470,000.00.

Need to look at a road levy for improvements in the future.

Worked with the roads department and county hired to repair the storm sewer pump station at Shoreland and Summit. It was not working during the spring flood. The pump was not repairable and needs to be replaced \$36,000.00 pump only. While we were there we sprayed the Phragmites along Summit Street from the bridge to the corner. I decided instead of our crews cutting them down Bryon asked the County to do it with their boom mower.

Bryon and I went to the County Engineers office and met with them about the repaving, water lines and the pump station repairs. They stated that the pump repairs in the future need to be paid by someone other then the County, should have been maintained by special assessment to the home owners, or storm water tax funds. They sent us Resolutions to approve, but we need to research them before we do anything. Also spoke to them about adding a new pump station down Shoreland Road. Shoreland from Summit Street to the Michigan line will no longer be a county road and will become a Township road and will be our responsibility to maintain it and repave it. Spoke with Doug Whiting of 5420 Patriot to remind him of his Court date tomorrow (September 21, 2018).

Spoke with neighbors to 5420 Patriot regarding the on going situation.

Worked with Bryon on the salt situation for the upcoming winter.

Worked with Bryon on getting the road repairs on Woodfox and Point Pleasant done. We got the repair down from \$10,000.00 for full repair to \$720.00 for spot repairs on Woodfox. They are both completed.

Mike Pniewski, Lucas County Engineers Office informed us on various methods to

finance the pump house repairs.

He aslo suggested doing a resolution charging residents \$5.00 for automotive registrations fee to help with road repairs.
