The Covid-19 pandemic has affected the Police Department in having to adapt in a more thought provoking and less personal nature than any of us have ever imagined! You may have noticed the Officers arriving masked up and gloved up; similar to something similar to a scene from a Science Fiction movie. We have been adhering to CDC, State of Ohio, and Lucas County Health Department guidelines for first responders. Additionally, in many cases when you call to report a crime, especially a "past offense non violent crime" the Officer will contact you by telephone rather than visit your location. Of course, any Life Threatening situation that may arise; we will respond to immediately. We ask that when you Call 9-1-1 you inform the Operator if someone in your residence or your location is ill or experiencing possible Covid-19 symptoms.

Above all else, continue to contact those folks that may be more vulnerable to this pandemic, if you feel that they may be in jeopardy do not hesitate to call 9-1-1 and advise the Operator of your concern.
