## All patrolman classified as Part Time Patrolman shall:

- 1. Provide a minimum of 24 hours per month of shift availability. There are no guarantees of shift assignments however all efforts will be made to provide the part time officers with as many shifts as possible.
- 2. Be required to provide availability for the Annual Summerfest Celebration and any other scheduled Township special function.
- 3. Provide shift availability in manner which aids the scheduling needs of the department.
- 4. Attend all scheduled and State of Ohio mandated training courses including participation in the annual firearms qualification date.
- 5. Perform tasks as needed to benefit the department and/or special project requirements.
- 6. Maintain all issued equipment in proper order.
- 7. Obtain full LEADS clearance within 30 days of appointment.
- 8. Maintain all passwords and clearances necessary to maintain access to AXON, MDT, OHLEG, Report Wise and other systems at all times and must be place within 30 days of appointment.
- 9. Sign a letter of commitment stating all necessary equipment to perform the duties required will be provided and failure to complete the probationary year will require a \$600.00 reimbursement to Washington Township upon separation.
- 10. The Washington Township Police Department shall maintain an officers OPOTA certification during their appointment.
