As we continue to move forward from the recent pandemic, it has forced us to make some significant and unprecedented changes to be able to provide our community with the continued fire & EMS service they expect and deserve. We understand that some of these changes may have gone against some of the rich traditions of this community, but we felt it was necessary as we move forward in providing quality service utilizing our current cost-effective model without burdening our residents with raising taxes to do so.

The Fire & EMS service is one of the most dynamic and everchanging services there is, we promise our residents that the WTFD will be progressive in meeting the constant change and challenges it brings, especially to small departments like ours with limited resources and funds. We believe in our departments mission statement; it helps us maintain focus in providing service to our community all while taking care of our departments most valuable assets...**Our firefighters**. Staffing by far is our biggest challenge, we rely heavily on paid-percall firefighters who live in the community and volunteer their time and availability 24/7/365 in providing service to our community. As volunteerism is down in this country, it has greatly affected the volunteer fire service. We have had to make significant changes to our current delivery model to keep up with this unfortunate trend. As you can see by the statistical data provided in this report, our run volume of calls for service has greatly increased, creating a significant challenge for our short-staffed department.

The main focus and department goal in 2022 was recruitment and retention. We developed a committee of current WTFD members who were tasked with developing a plan to aggressively recruit members of our community to join the WTFD. These efforts brought 3 new members to the ranks in 2022 and will be a continual focus effort as we move forward. #### **2022** Accomplishments

- For the first time in department history, we hired our first full-time firefighter. Captain Jacob Cook was hired into this position and assists with day-to-day operations in managing the station, day shift operations, assist with other administrative duties and serve as the department's fire safety inspector.
- We were successful in obtaining grants which allowed us to replace outdated safety equipment for our firefighters.
- We placed in-service new self-contained breathing apparatus (SCBA's) with funds received from the FEMA Assistance to Firefighters Grant at a total cost of \$122,000.00.
- We utilized CARES act fund to purchase 13 new Motorola 800 MHz portable radios at a cost of around \$56,000.00.
- Completed and updated the department's policies and procedures to the Lexipol platform. This allows the department to operate utilizing policies and procedures that are court tested meeting state and federal regulations protecting the department and township.
- Developed comprehensive preventive maintenance program for our fleet of vehicles. This PM program will follow the NFPA 1911 standard for inspection, maintenance, testing of in-service vehicles in an effort to maintain and extend serviceability of our vehicles and assure safety for our firefighters.

- Jake Cook completed the Ohio Fire Safety Inspector course. This enhances our Fire Prevention abilities to perform fire inspections on Township businesses.
- Chad Klavinger completed his probationary year requirements and was promoted to Firefighter/EMT in March.
- Michael Roberts completed his EMT-Basic certification.

- Sharralynn Cook completed her Paramedic course work and will be obtaining Ohio Paramedic certification in 2023.
- Tom Yunker completed his Paramedic course work and will be obtaining Ohio Paramedic certification in 2023.
- 3 new members joined our fire family.
  - Jody Gruesbeck joined the department in June and came to us with her Ohio EMT certification. She will be continuing her education with Paramedic school in 2023.
  - Rob Rudski joined the department in June. Rob completed the Ohio Firefighter 1 training in December and will be moving forward with EMT training in 2023.
  - Mark Schuster II joined the department in August and will be moving forward with Firefighter and EMT training in 2023.
