Contacted former state rep to ask about Governor letting us fly the flag at half-mast. If it was a current official in office could ask. Not done for a past fire fighter. Discussed flag code.

Researched flag code because a resident reached out and had an issue with the flag being lowered for Bob Green. Found no criminal act or repercussions if a flag is lowered. Zero financial or criminal risk to the township. Spoke to Leo and he did research on the proper way to honor a fallen fire fighter and we bought a new flag and also a township flag is being made.

**Chief Ron Kay – Fire Department  
Report for Tuesday, March 14<sup>th</sup>, 2023**

Completed training and “Go Live” implementation of the Properties and Inspections module to our ESO electronic record keeping program. This module will be used to keep records of all township businesses and places of public assembly as well as producing fire code inspection reports.

Chief Kay has been attending meetings with Lucas County and area fire chiefs in regards to the future of ALS service in Lucas County.

Department hosted an alumni luncheon on 3/5/23. Event was very well attended by many past members of the WTFD.

Chief Kay investigated with State Fire Marshall investigator 2 suspicious fires in the Raintree Village Mobile Home Park.

## **Chief Chris Kaiser – Police Report for Tuesday, March 14, 2023 Meeting**

I attended and represented Washington Township at funeral services for retired Toledo Police Chief and Former Police Chief of Ft. Myers, Fl. Derrick Diggs.

We received notice that the case of Harper Flowers that involved a pursuit and drugs charges on 2-23-23, has been resolved. Mr. Flowers agreed to forfeit \$4423.00 to the police drug fund and he was sentenced to 6 months in jail.

PtIm. Todd Mocniak was sworn in and has an effective start date of March 1, 2023 He has been issued his equipment, completed his firearms qualifications and started his in-house training. Will be signing a conditional letter of employment

Detective Hart reports that a rape case that he was working on has been settled after an arrest was made. The suspect has pled to a charge in Common Pleas Court and was sentenced to 8 to 14 years in prison.

We have finally concluded the felony drug case involving a 2018 Genesis vehicle which we confiscated. The suspect agreed to a plea deal and will be sentenced later this month. The police department will see a substantial monetary amount after he is sentenced from this case. Estimated amount \$7500.00 up to \$30.000 from this case.

We took a felonious assault report from St. Vincent's Hospital in which a young female was severely beaten in Raintree Village. She had her nose broken and cell phone stolen. The incident was investigated and arrest warrants were issued for the suspect.

The unclaimed (PT Cruiser) on Gov deals auction site was sold last month for \$816.00. Obtained another title to unclaimed car (Saturn Vue) to be auction soon.

Will not be renewing the Leads Online subscription to an investigative database of pawned and stolen property. We have used this service for approximately 10 years. Due to budget constraints, we will forgo this service and save \$1635.00.
