## **GUIDELINES FOR PUBLIC COMMENTARY**

- a. The Chairman of the Board of Zoning Appeals shall open the hearing for public comment.
- b. Please wait to be recognized or acknowledged by the Chair before speaking.
- c. Secretary will administer oath to anyone wishing to speak.
- d. The time allotted to any one speaker is limited to 5 minutes with the exception of the applicant and his/her agent or representative.
- e. The Applicant shall have the first option to address the board, and may also be the final public comment.
- f. When it is your turn to speak, begin by clearly stating your name and address at the podium.
- g. Present your statement of concern, comments, opinion, or questions to the Board of Zoning Appeals.
- h. The Board will hear comments from the audience one at a time, but may defer any action or response to gather further information and study all aspects of the matter brought to their attention.
- i. The Washington Township Board of Zoning Appeals pledges its courteous attention to those who wish to be heard. In return, the Board asks that members of the audience refrain from talking, whispering, and other distractions during the meeting.

- j. A person shall not be excluded from a public hearing except for a breach of peace as determined by the Chairman of the Board.
- k. After the public comment portion of the meeting is closed, the public will not be involved in the variance discussion process.
- 6. BUSINESS
  - Appeal request of <u>Michael Vaillant</u> of <u>2453 Point Pleasant Way</u> in Washington Township, Lucas County, Ohio, who is requesting a variance of zoning resolution section 1301 C, specifically, to allow a garage placement that extends into the required side yard setback.
